**RULES & REGULATIONS FOR Dealer/Exhibitors**

Assignment of space will be by show management. We will try to accommodate special requests as possible, but cannot guarantee space. Table space/rentals will be first come basis.

No Exhibitor is to offer for sale any pornographic material, contraband, stolen goods or items which are illegal to own, possess or sell under federal, state, or local laws. The Organizer reserves the right to order the removal of any item offered for sale which, in its opinion, is in bad taste.

**Sales Tax:** Applicant agrees to be solely responsible for and to pay any and all applicable taxes, license fees and permits that may be required in connection with applicants participation in the show.

We are not responsible for merchandise missing from any table during the show.

Each Exhibitor agrees to comply with pertinent federal, state and local laws and ordinances while on the show premises.

Each Exhibitor agrees to wear his/her identification badge and shall insure that his/her employees wear their badges. No badges are to be given out to or allowed to be worn by persons other than Exhibitors and their designated employees. All dealers/exhibitors and their helpers must be either Expo Registrants or PEZ Convention registrants.

No booths are to be closing down until 2PM unless, in the discretion of the Organizer, Exhibitors are directed to do so, pursuant of these Rules and Regulations. All Exhibitors will be packed and out of the show by 5PM. If the exhibitor is not out by 5PM they will be responsible for any "overtime" fees charged by the hotel.

If any shows are canceled or terminated for any reason whatsoever, the Organizer shall not be responsible to the Exhibitor for any damages, loss or injury occasioned by such cancellation or termination of the show prior to its scheduled conclusion date.

Cancellations must be 14 DAYS in advance of the show for a refund. A \$25.00 fee will be charged on all returned checks.

The Exhibitor agrees to indemnify and save harmless the Organizer and shall not hold Organizer liable for any defects, damage, injury or loss arising out of or occurring in connection with the use of the leased space or grounds utilized in the show, including the display area, entrance areas, parking areas, rest rooms, etc. as these are leased by the owners of said facilities, to the Organizer.

The Show Manager has final say in all respects.
